One in particular which has recently come to our attention is that of livestock. Residents are prohibited from keeping chickens, geese, goats, cows, sheep, etc. on their property. While we have received a few complaints recently we haven't located the "home" of the livestock yet. We would appreciate voluntary compliance with the CC&R's.
Meetings, meetings	Needless to say, it has been a busy few months for Hidden Valley. We have attended several hearings and testified on behalf of what the board has determined to be issues that matter to Hidden Valley. We've let the Pima County Board of Supervisors know how we feel about the recently approved treatment facility on the former Fenster School property and lamented the condition of the roads in our neighborhood and that of the County. Neighborhood Watch Meeting	The Annual Neighborhood Watch Meeting scheduled for March 10, 2015 has been postponed. We will reschedule after we have our program more fully defined.		
Neighborhood Blocks	We are making progress on redefining the Neighborhood Watch block units. Pat Packard has been working on making the map readable and user friendly. I have emailed and called most of the people on the list that I was given by Leland Montell but have only had responses from the folks listed below as actively wanting to participate.

Block Leader Responsibilities	As a block leader your responsibility is to keep the Director up to date on any criminal activity on your block. You'll be asked to welcome new neighbors to your watch area. Block Leaders are asked to host one meeting a year for the neighbors on their block.		

## **Plma County Fire Districts - Property Taxes**

Frank Sax, HVHOA member, is a member of the Hidden Valley Fire District Board. He shared the following information:

Each fire district gets its money, to pay expenses and capital costs, from taxes on the property of its members. Some districts have stations, vehicles, and personnel; others contract services from Rural/Metro Corp, or districts which can provide those services. Four fire districts on the northeast side contract with Rural/Metro. Fire districts which actually do the work are shown below for comparative purposes.

The median market value of Hidden Valley FD property is \$300,000, so the median annual property tax for the fire district is \$240. Tucson CC Estates has a 50% higher median market value, and a higher tax rate, so their median annual property tax approaches \$400.

The maximum tax rate by law is \$3.25, which applies to Picture Rocks and several small fire districts, and would be applied to median market values of their properties, which is \$80,000 for Picture Rocks (for a tax of \$260).

### Sabino Recovery - Integrative Behavioral Health & Wellness

#### **February 17th**

Today the Pima County Board of Supervisors voted to approve the application of Sabino Recovery LLC to open a 55 bed residential substance abuse diagnostic and treatment facility on the former Fenster School property. As you know, your board of directors also voted unanimously to support Sabino Recovery's application, as did the other HOA which borders Fenster. There were a few people who spoke in opposition, most citing the inappropriateness of a treatment facility in a residential neighborhood. However, the Fenster family is free to lease or sell the property to anyone who can get the permits, and we felt this option was the best of other potential uses. One other we are aware of was a facility for treatment of troubled youth.

Representatives from Sabino Recovery assured us after the meeting that they intend to be good neighbors, and we intend to hold them to that commitment. We will continue to have discussions with them as they move forward. Jack O'Donnell will be at the March 30th Board meeting to meet people and address questions.

- Owners of Sabino Recovery LLC are Pat Manley, Thomas Isbell, Nancy O'Donnell and Jack O'Donnell. All are licensed behavioral health professionals with extensive experience in the field.
- They plan extensive landscaping and interior improvements
- The exteriors of the buildings they use will remain the same
- Individual and group therapy to private pay patients who will be charged \$1100 - \$1500 a day
- The program duration is 35 days
- Most of their clients will be from out of town
- All participants will be in the program voluntarily
- Felons or sex offenders will not be accepted in the program
- Participants will be picked up at the airport and transported to the facility
- Program participants will not be allowed off the premises
- Buildings will be locked at night and there will be 24/7 security


