## Hidden Valley Homeowners' Association Board of Directors Meeting February 5, 2025

Our Guest Speaker was Catlow Shipek from Watershed Management Group (WMG). His associate, Jace Lankow, was also present. They discussed water issues in our area. We are in a shallow groundwater aquifer (less than 50 feet beneath the soil to water). Wes Miller Park is special in that it is one of the few streams in the area to have water year round. WMG is monitoring wells in the area to measure water levels.

Catlow mentioned three plants that are invasive, fire prone and flammable: arundo, buffel grass, and stinknet. More information about these can be found on their website, www.watershedmg.org.

Catlow also put in mention of the WMG's River Run Network, which actually started out right here in Wes Miller Park with a campaign of cleaning up the creek and invasive plant removal. He said there are several opportunities to get involved.

Minutes of the December 4, 2024 Board Meeting were approved as published on our website.

The Secretary noted that our March meeting will be held Wednesday, March 5, 2025 at the Bergan's home. This will be our candidate selection meeting for the Association Board. All members are encouraged to attend and consider running for office. We are looking for a vice president and a web content manager.
